SPEAKERS

SHANA ALTMAN EARNED A BACHELOR'S DEGREE IN COMMUNITY HEALTH EDUCATION FROM ILLINOIS STATE UNIVERSITY AND EARNED THE DESIGNATION OF CERTIFIED HEALTH EDUCATION SPECIALIST IN 2008. SHE HAS SERVED AS THE FOODBORNE AND ENTERIC DISEASE PROGRAM MANAGER WITH THE COMMUNICABLE DISEASE CONTROL SECTION AT THE ILLINOIS DEPARTMENT OF PUBLIC HEALTH SINCE 2016. PRIOR TO WORKING AT IDPH, SHE WORKED AS THE PUBLIC HEALTH EMERGENCY RESPONSE COORDINATOR AT THE LOGAN COUNTY DEPARTMENT OF PUBLIC HEALTH FOR 6 YEARS.

CHIRAG BHATT HAS BEEN INVOLVED IN THE FOOD SAFETY INDUSTRY FOR 4 DECADES. AFTER WORKING WITH A LOCAL REGULATORY AGENCY (CITY OF HOUSTON) FOR OVER 26 YEARS, CHIRAG WORKED WITH A CUSTOM SOFTWARE COMPANY AS A VP, FOOD SAFETY AND CLIENT CONSULTING FOR A FEW YEARS PRIOR TO JOINING A LARGE RESTAURANT COMPANY (BLOOMIN BRANDS) AS THEIR GLOBAL REGULATORY COMPLIANCE MANAGER. HE ALSO WORKED WITH A MAJOR DISTRIBUTION COMPANY (SYSCO CORP) AS REGULATORY AND TECHNICAL SERVICES DIRECTOR. HE RECENTLY WORKED WITH A RETAIL COMPANY (BUC-EE'S) AS A DIRECTOR OF FOOD SAFETY AND QA FOR 2 YEARS. CURRENTLY, CHIRAG IS THE DIRECTOR OF REGULATORY AFFAIRS (ENVIRONMENTAL HEALTH) WITH HS GOVTECH – A COMPANY PROVIDING SAAS (SOFTWARE AS A SOLUTION) FOR OVER 800 ENVIRONMENTAL HEALTH DEPARTMENT AGENCIES IN NORTH AMERICA. CHIRAG HOLDS A BS IN BIOLOGY AND CHEMISTRY. HE HAS BEEN ACTIVELY PARTICIPATING IN THE CONFERENCE FOR FOOD PROTECTION SINCE 1998 AND HAS SERVED IN MANY ROLES. HE IS A RS WITH THE STATE OF TEXAS AND ALSO HOLDS – CERTIFIED COMPREHENSIVE FOOD SAFETY (CCFS) CREDENTIAL FROM NEHA. HE HAS SERVED AS CHAIR FOR THE NATIONAL REST ASSN'S QA EXECUTIVE STUDY GROUP FOR THREE YEARS. CURRENTLY, CHIRAG SERVES AS AN EDUCATION ADVISORY BOARD MEMBER WITH FOOD SAFETY SUMMIT AND IS AN ADVISORY COUNCIL MEMBER WITH SANI PROFESSIONAL. HE LIVES IN THE GREAT STATE OF TEXAS.

ERIC BRADLEY (MPH, REHS, CP-FS, DLAAS) IS THE DEPUTY HEALTH DIRECTOR AT THE LINN COUNTY PUBLIC HEALTH DEPARTMENT IN CEDAR RAPIDS, IOWA. HE HAS WORKED IN ENVIRONMENTAL HEALTH FOR MORE THAN TWENTY-FIVE YEARS AT COUNTY HEALTH DEPARTMENTS IN GEORGIA, ILLINOIS AND IOWA, INCLUDING SIX YEARS AS ENVIRONMENTAL HEALTH MANAGER AT THE SCOTT COUNTY HEALTH DEPARTMENT IN DAVENPORT, IOWA. ERIC IS THE EXECUTIVE SECRETARY/TREASURER OF THE AMERICAN ACADEMY OF SANITARIANS, A PAST-PRESIDENT OF THE IOWA ENVIRONMENTAL HEALTH ASSOCIATION AND ACTIVE WITH SEVERAL LEGISLATIVE/ADVOCACY COMMITTEES IN IOWA. HE IS A TECHNICAL ADVISOR (FOOD SAFETY AND DEFENSE) FOR THE NATIONAL ENVIRONMENTAL HEALTH ASSOCIATION AND A PEER REVIEWER FOR NEHA'S JOURNAL OF ENVIRONMENTAL HEALTH.

HUNTER BUCHANAN IS A GRADUATE PUBLIC SERVICE INTERN (GPSI) WITH THE ILLINOIS DEPARTMENT OF PUBLIC HEALTH FOOD PROGRAM. PURSUING MASTERS DEGREE IN ENVIRONMENTAL SCIENCE WITH A CONCENTRATION OF ENVIRONMENTAL PLANNING AND MANAGEMENT AT THE UNIVERSITY OF ILLINOIS SPRINGFIELD. INTERESTS INVOLVE FOOD SAFETY AND SUSTAINABILITY OF LOCAL FOOD SYSTEMS.

DORI BUGAJSKI IS A LICENSED ENVIRONMENTAL HEALTH PRACTITIONER WITH 34 YEARS OF EXPERIENCE AT THE ILLINOIS DEPARTMENT OF PUBLIC HEALTH. SHE IS A GRADUATE OF ILLINOIS STATE UNIVERSITY WITH A BACHELOR'S DEGREE IN ENVIRONMENTAL HEALTH. DORI HAS A LONG HISTORY OF INSPECTING AND REGULATING FACILITIES IN ALL ASPECTS OF THE GENERAL ENGINEERING PROGRAM SUCH AS SWIMMING FACILITIES, MANUFACTURED HOME COMMUNITIES, YOUTH CAMPS, CAMPGROUNDS, AND NON-COMMUNITY PUBLIC WATER SUPPLIES. HER APPROACH TO PUBLIC HEALTH REGULATION EMPHASIZES COLLABORATION AND PARTNERSHIP WITH THE FACILITIES SHE OVERSEES. SHE IS COMMITTED TO ACHIEVING COMPLIANCE FOR THE PURPOSE OF PROTECTING THE HEALTH AND WELFARE OF THE PUBLIC. DORI IS CURRENTLY SERVING AS PUBLIC SERVICE ADMINISTRATOR OF THE WEST CHICAGO REGIONAL OFFICE AND WAS RECENTLY SELECTED TO SERVE AS CENTRAL CHAPTER VICE- PRESIDENT OF THE ILLINOIS ENVIRONMENTAL HEALTH ASSOCIATION.

THOMAS BUTTS, MSC, REHS HAS BEEN A NEHA MEMBER FOR 36 YEARS AND WAS ELECTED IN 2019 TO THEIR BOARD OF DIRECTORS. HE CURRENTLY WORKS ON ENVIRONMENTAL HEALTH PROGRAMS AS A CONSULTANT AND AS AN HOURLY EMPLOYEE FOR TWO LOCAL HEALTH AGENCIES IN COLORADO. TOM WAS ALSO APPOINTED TO THE COLORADO STATE BOARD OF HEALTH REPRESENTING LOCAL GOVERNMENTAL ENVIRONMENTAL HEALTH IN MARCH OF 2019 AND CURRENTLY SERVES AS THE PRESIDENT. PRIOR TO HIS RETIREMENT IN 2017, HE SPENT HIS CAREER WITH TRI-COUNTY HEALTH DEPARTMENT, THE LOCAL PUBLIC HEALTH AGENCY THAT SERVES THREE COUNTIES AND OVER 1.5 MILLION PEOPLE SURROUNDING DENVER WORKING IN GENERAL ENVIRONMENTAL HEALTH, HAZARDOUS WASTE, EMERGENCY PREPAREDNESS AND AS AGENCY DEPUTY DIRECTOR. THROUGHOUT HIS CAREER, TOM HAS SERVED IN LEADERSHIP POSITIONS WITH MANY ENVIRONMENTAL HEALTH ORGANIZATIONS, INCLUDING AS A REGIONAL REPRESENTATIVE, TREASURER, AND THEN PRESIDENT OF THE COLORADO ENVIRONMENTAL HEALTH ASSOCIATION (CEHA). HE RECEIVED HIS BS IN EH FROM COLORADO STATE UNIVERSITY AND MSC IN ENVIRONMENTAL SCIENCE AND ENGINEERING FROM COLORADO SCHOOL OF MINES.

LAURA CARLIN COCHRAN, MPH. HAS SERVED AS DUPAGE COUNTY HEALTH DEPARTMENT'S PROTECT SWIMMERS 10M PROJECT COORDINATOR SINCE 2018. LAURA STUDIED PUBLIC HEALTH AT NORTHERN ILLINOIS UNIVERSITY AND THE UNIVERSITY OF ILLINOIS CHICAGO AND HAS WORKED IN THE AREA OF CHILD AND ADOLESCENT HEALTH FOR OVER TWO DECADES. LAURA ALSO TEACHES GRADUATE-LEVEL PUBLIC HEALTH POLICY AND ADVOCACY COURSES FOR THE UNIVERSITY OF ILLINOIS CHICAGO SCHOOL OF PUBLIC HEALTH AND LIVES IN WHEATON WITH HER FAMILY.

SPEAKERS

DR. BRIAN CHEN IS AN ASSOCIATE PROFESSOR OF PUBLIC HEALTH AND THE CHAIR OF THE MASTER OF PUBLIC HEALTH (MPH) PROGRAM AT THE UNIVERSITY OF ILLINOIS SPRINGFIELD (UIS). HE EARNED HIS PH.D. IN HEALTH BEHAVIOR AND TWO MASTER'S DEGREES (E.G., IN APPLIED STATISTICS) FROM INDIANA UNIVERSITY SCHOOL OF PUBLIC HEALTH-BLOOMINGTON. HIS PROFESSIONAL TRAINING HAS FOCUSED ON HEALTH BEHAVIOR, APPLIED STATISTICS, AND EVALUATION RESEARCH. DR. CHEN'S RESEARCH FOCUSES ON THREE MAJOR THEMES TIED TO EMERGING PUBLIC HEALTH ISSUES, WITH A FOCUS ON SOCIAL DETERMINANTS OF HEALTH, HEALTH EQUITY, AND E-EDUCATION AND HEALTH COMMUNICATION. THESE THREE THEMES CONNECT TO A VARIETY OF SCHOLARSHIP ACTIVITIES AND PRODUCTS IN HIS RESEARCH PROJECTS AND PROPOSALS. THEY INCLUDE 1) HEALTH BEHAVIORAL RESEARCH, 2) E-EDUCATION IN PUBLIC HEALTH, AND 3) PUBLIC HEALTH INTERVENTION (E.G., FOOD SAFETY EDUCATION) AND EVALUATION RESEARCH. DR. CHEN LAID THE GROUNDWORK FOR THE PROPOSED RESEARCH BY DEVELOPING EFFECTIVE MEASURES OF THE IMPACT OF A NON-PROFIT FOOD PANTRY PROGRAM ON FOOD INSECURITY IN ILLINOIS AND BY DEVELOPING ONLINE GAMIFIED EDUCATIONAL ACTIVITIES AND EVALUATING STUDENT LEARNING OUTCOMES IN BIostatISTICS. MOREOVER, HE HAS BEEN ACTIVELY ENGAGED IN FACULTY-LED STUDENT RESEARCH, SUPERVISING 12 MASTER OF PUBLIC HEALTH (MPH) RESEARCH MENTEES AND THREE DOCTORAL STUDENTS FROM THE DOCTOR OF PUBLIC ADMINISTRATION PROGRAM AT UIS. IN BRIEF, DR. CHEN IS A PASSIONATE PUBLIC HEALTH EDUCATOR AND RESEARCHER. HE IS COMMITTED TO USING HIS EXPERTISE TO IMPROVE THE HEALTH AND WELL-BEING OF INDIVIDUALS AND COMMUNITIES.

DAVE COLBERT IS THE VICE PRESIDENT OF SALES FOR XCLUDER. WITH 17 YEARS OF EXPERIENCE WORKING WITH PEST MANAGEMENT PROFESSIONALS IN NORTH AMERICA, EUROPE AND ASIA, DAVE HAS PLAYED A KEY ROLE IN THE DEVELOPMENT AND GROWTH OF THE GLOBAL EXCLUSION MARKET. HE HAS SPEARHEADED THE DEVELOPMENT OF MANY OF THE EXCLUSION TECHNOLOGIES AVAILABLE IN THE XCLUDER CATALOG. A PARTICIPANT IN BOBBY CORRIGAN'S RODENT ACADEMY, DAVE WORKS WITH FACILITY MANAGEMENT TEAMS AND PEST MANAGEMENT PROFESSIONALS TO DEVELOP EXCLUSION STRATEGIES FOR A WIDE VARIETY OF INDUSTRIES INCLUDING SCHOOLS, UNIVERSITIES, MUSEUMS, RETAIL CHAINS, GROCERY STORES AND FOOD SERVICE, DISTRIBUTION AND MANUFACTURING FACILITIES.

DEREK DELAND IS THE ENVIRONMENTAL HEALTH PROGRAMS MANAGER IN NSF'S REGULATORY AFFAIRS DIVISION. IN THIS ROLE HE SERVES AS A POINT OF CONTACT FOR LOCAL AND STATE REGULATORY AGENCIES PROVIDING SUPPORT WITH RESPECT TO NSF STANDARDS, CERTIFICATIONS, AND SERVICES. DEREK CAME TO NSF AFTER 19 YEARS AT A LOCAL HEALTH DEPARTMENT IN MICHIGAN WHERE HE SERVED AS A SANITARIAN AND ENVIRONMENTAL HEALTH DIRECTOR.
